Casting a Ballot by Mail

- A common practice in the United States, with variations.
- For most Americans, we request an absentee ballot by mail.
- The behind-the-scenes process is pretty complicated.











VOTE BY MAIL

For the 2020 General election this November, do you approve or disapprove of states using only vote by mail instead of voting in person?

Universal Vote By Mail

- Every registered voter is mailed a ballot
- These states typically include online voter registration, and some include Automatic Voter Registration
- In-person voting is maintained through drop boxes and vote centers
- Process that is implemented over time



No Excuse Absentee (Illinois is in this category)

- Most common form of mail voting in America
- Voters do not need to submit an excuse about why they cannot vote in person on Election Day
- Voters must submit an application in some states, this requires additional information
- Ballot is then mailed to the voter, who must return the ballot within a specific timeframe



Excuse Absentee

- Considered the most restrictive in terms of vote-by-mail
- Voter must provide an acceptable excuse as to why they cannot vote in person
- These states have lower level of Absentee Ballots cast

What are some Current Proposals?

- Mail every registered voter a ballot
- Mail every registered voter a ballot request form
- Require that election authorities provide prepaid postage
- Extend early voting periods
- Overhaul elections infrastructure



What is Happening in Illinois?

- Prepare for the likely increase of mail ballots
- Retaining early voting and in-person voting locations,
 - while practicing CDC guidelines of social distancing and sanitation
 - ensure that we are not disenfranchising communities with which mailing a ballot may not be feasible.
- Need to recruit younger election judges



Important Dates for November





Indivisible IL Position

- ASKS: we need to get more ballots to more people
 - Every registered voter should get a ballot AND ensure that all jurisdictions include envelopes with prepaid postage for all voters
 - Expand early voting
 - A statewide ballot tracking mechanism must be created to remove any barriers to receiving, tracking and returning an absentee ballot
- Mission Statement: We demand safe, secure and accessible elections to protect the right to vote during the pandemic and beyond
